Applicant represents that: (1) the person signing this credit application is expressly authorized to enter into an agreement for arrangement of the transportation of freight and/or other related logistics services on behalf of Applicant as well as to seek credit for such purposes; (2) any agreement for arrangement of the transportation of freight or other related logistics services is binding on Applicant; and (3) Applicant consents to venue of any legal action in Shelby County, Memphis, Tennessee.
